- 1. Minutes of the Meeting of the Council held on 16th October 1986, which had been previously circulated, were confirmed as a true record and signed by the Chairman.
- 2. Matters arising from the Minutes of the last two Meetings

Best Kept Village Competition The Chairman thanked all those who supported him at the presentation on 28th September.

Probation Service The Clerk reported that he had met a member of the Service about further work at the Town Hall. RESOLVED that external decoration be carried out if it can be done from ladders, but that the polishing of the floor be not proceeded with.

<u>Castle Grounds</u> The Chairman reported that this Committee had met and would be reporting when the Cemetery Committee had met.

Castle Street The Clerk reported that the County Council would inspect the positioning of the sign at the bend but had made no comment on the possibility of double white lines. RESOLVED that this point be stressed to the County Council.

Town Hall electricity supply The Clerk reported that a much higher tender had been received from the Electricity Board and that Mr. Hirons had satisfied the Chairman and himself on certain points. The work had therefore been carried out by Mr. Hirons.

<u>Windmill Centre committee</u> The Clerk reported that a meeting had been arranged between Members and members of the committee for 4th November at the Centre.

## 3. Items of correspondence

Planning appeal It was reported that the Department of the Environment had dismissed the appeal against Planning refusal for the erection of a single dwelling at 2 Duns Tew Road.

B4031 The Clerk reported on a letter sent by Mr. Berridge to the member of Parliament about the weight restriction proposal and the opposition of Adderbury Parish Council to this suggestion. Councillor Marmion stated that he understood that the Member did not wish to take sides in the matter. Highway works Proposed edge strengthening at Danes Hill was reported.
