# **Allotment Tenants' Privacy**

### **Notice Allotment Tenants' Privacy Notice**

When you sign and return your Allotment Tenancy agreement, the information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and respond to your correspondence and send invoices relating to your allotment tenancy. Your personal information will be not shared or provided to any other third party other than Chair and Treasurer if the Allotment Society who assist the Parish Council and manage the allotment site in Satin Lane.
