### DEDDINGTON PARISH COUNCIL

### Minutes of the Extraordinary Meeting of the Parish Council held Monday, 10th May, 1993

Present:-

Councillors Oddy (Chairman), Barlow, Bowen, Canning, Clarke, Clinch, Mrs Lee, O'Brien, Mrs Swash and Todd.

#### 194/92 Apologies for Absence.

Apologies were received from Councillors Miss Hill, Reed, Mrs Stevens and Mrs Garvey and County Councillor Matthews.

## 195/92 Windmill Centre - Current position re contract.

Councillor O'Brien reported that documents had been forwarded to 5 possible main contractors and that following correction the lowest was £419,152 or £107,337 over the budget sum. The reasons for this substantial variation were:-

(a) the onerous planning requirements re tree planting,

(b) additional parking requirements required by the planners

(c) certain late additions to the contract and

(d) refinements to the hard landscaping.

Basically the individual major items within the tender e.g. works to the Centre building, the pavilions and bowling green.

In order to proceed the following omissions had been effected with the stated cash saving

(1) Multi-use court 30,739 (2) Toddlers Play Area 25,000 5,346

(3) Ball Stop Fence

(4) Reduction in paving, certain areas of planting, 1 year post contract maint. instead of 2 42,000

It will be necessary to prioritise, as soon as possible, these omissions in order that some may be reinstated from grants received and unused contingencies.

The contract was awarded to Barrett Builders (Kidlington) Ltd with a completion date of 14th October, 1993.

The following questions were then asked and answered:-Cr Canning - Has planting on south side been reduced to minimum? - Yes

Cr Todd - Worry regarding the proximity of trees to the Bowling Green? - It was explained that there was to be a 5 metre extension of open area to the south of the green and on the southern side of the beech hedge which surrounds the green, which would help to shield the green from leaves.

Cr Canning - The reinstatement of the toddlers play area should be high on the list of priorities? - Noted

Cr Clinch - When would the pavilions be available? - It is a contract condition that the cricket pavilion should be available by 30th June and the contractor had stated that it was his wish to erect the pavilions one after the other. Cr Todd - When will the works to the bowling green be finished?

- the sub-contract period for this item is 10-12 weeks. Cr Todd - What is the cost of the loss of one years maintenance

of the green? - The first year's cost is £16,300 and the ssecond year would have been £10,000 to £12,000.

Cr Bowen - It is usual for bowling greens to be maintained by

Cr Clinch - It is an urgent matter for the Council to decide who will maintain the grounds in totality. The Chairman stated that the Windmill Sub-Committee would be recommending to Council regarding future maintenance.

Cr Clarke - The initial cost of the sports field was financed by the Council, could not the bowling green be treated on a similar basis? - Initially the bowling club asked the Council for a grant of £20,000 and a loan of a similar figure when the
