- Ward be elected Chairman of the Council for the ensuing year.


 Councillor Ward then signed his Declaration of Acceptance of Office & took the Chair,

4. Matters arising from the Minutes

Planning applications This matter was further discussed especially in relation to Castle End and the Clerk reported on correspondence he had had with the Chief Planning and Development Officer. FURTHER RESOLVED that the District Councillor be invited to attend an early meeting of the Council to have a general discussion with a view to a good working relationship being set up for the term of office.

Also RESOLVED that the Vice Chairman be appointed to replace Mr. Spencer on the group advising on the Windmill Community Centre.
- 8. OALC Annual General Meeting RESOLVED that Councillor George be appointed to attend this meeting with the Clerk.



9. <u>Planning applications</u> No objections were made to the following planning applications:-

CHN.207/82 Chach house, The Hermitage, Market Place; CHN.208/82 College Farm, Hempton. In connection with the C uncil notice board which was formerly on this site, Councillor Webber agreed to try and find another position for it in the village.

10. <u>Market stall</u> A verbal application was received from Mr. R. West of 12 High Street for permission to have a stall under The Town Hall on 29th May for the sale of general merchandise, with the possibility that he might make future applications. After some discussion, RESOLVED that permission be granted at a charge of £1 for this occasion, subject to Mr. West obtaining all necessary consents, being responsible for any third party claims, and leaving the site in a clean and tidy condition before he leaves it.
