

MINUTES OF THE ANNUAL MEETING OF DEDDINGTON PARISH COUNCIL HELD ON 22ND MAY 1985

Present: Councillors Mrs. Cheeseman, Fenemore, Gardner, Garrett, Garvey, Hayward, Mackenzie, O'Neill, Mrs. Robinson, Stevens, Ward and Webber.

1. To elect a Chairman for the ensuing year It was moved by Councillor Mrs. Robinson, seconded by Councillor Garrett and unanimously RESOLVED that Councillor Ward be elected Chairman of the Council for the ensuing year.

Councillor Ward then signed his Declaration of Acceptance of Office and took the Chair.

2. Retiring Chairman It was unanimously RESOLVED that a vote of thanks be recorded to Councillor Mrs. Robinson for the way in which she had conducted the affairs of the Council during her two-year term of office.
3. Apologies for absence were submitted on behalf of Councillor Fuller.
4. To elect a Vice-chairman for the ensuing year It was moved by Councillor Garrett, seconded by Councillor Mackenzie and unanimously RESOLVED that Councillor Hayward be elected Vice-chairman of the Council for the ensuing year.
5. Minutes of the Meeting of the Council held on 24th April 1985, which had been previously circulated, were confirmed as a true record and signed by the Chairman.
6. Matters arising from the Minutes

Boulderdyke Farm A reply from the Chief Environmental Health Officer, which stated that action had been taken to reduce the problems, was reported.

Cemetery RESOLVED that Mr. Holton be thanked for again cutting the front hedge and, in response to his query, that he be asked to cut the side hedges as well next time.

Highway matters A progress report from the Area Surveyor was reported.

Circus Reference was made to the rubbish left by the circus and RESOLVED that the District Council be asked to clear it.

Town Hall canopy A report was given on the circumstances under which two residents held their stall on 18th May.

Deddington High Street Garage A letter from the Chief Planning and Development Officer stating that Messrs. Bankier Sloan were claiming that there was an established office use. RESOLVED that he be advised that the Council considered that the premises were part of the garage workshop until recently.

7. Dates and times of Meetings RESOLVED that Meetings be held on the fourth Wednesday in each month at 7.15 p.m., with the exception of December when it be held on the third Wednesday.
8. Membership of Planning Committee RESOLVED that the members of the Planning Committee be the Chairman, Vice-chairman and Councillors Mrs. Cheeseman, Garrett, O'Neill and Stevens.

Dogs fouling footways byelaws The notice produced by the District Council was displayed and RESOLVED that fifteen copies be ordered with the sitings to be agreed at the next Meeting.

Guided walks in the District The Chairman agreed to display the details.

Spring Bank Holiday District Council arrangements were reported.

Cherwell Edge Golfcourse Publicity material was reported.

Reservoirs Act 1975 A letter from the County Council, which did not appear to affect the Parish, was reported.

Footpath rear of The Daedings A letter was reported which complained of recent dumping of rubbish and the Clerk was instructed to write to the culprit asking him to refrain from the practice.

10. Castle Grounds Details were given of suitable swing seats and Councillor O'Neill offered to inspect the existing swings to see how they could be adapted and then advise the Clerk so that new seats could be ordered.
11. Parish Liaison Meeting It was reported that this meeting would be held at Bodicote House on 19th September at 7 p.m.
12. Windmill Centre

(a) Rockwell proposals Councillor Mrs. Robinson reported that the Planning applications had been deferred by the District Council, but that the Football and Cricket Clubs were now in agreement with the proposals: the purchase of a strip of land had now been finalised; and that the County Council were negotiating over the restrictive covenant which applied to the agricultural land.

(b) Financial working group RESOLVED that Councillors O'Neill and Mrs. Robinson continue to serve on this group.

(c) Accounts of the committee for 1984/85, which had been circulated to all Members, were noted.

13. Planning applications No objections were made to (a) an extension at 8 County View; or to (b) an outline application for a single dwelling at The Tchure.

MINUTES OF THE DEDDINGTON PARISH MEETING HELD ON 22ND MAY 1985 AT 7.15 P.M.

Present: Councillor Mrs. Robinson (Chairman), twenty local government electors and the District Councillor.

1. Minutes of the Parish Meeting which had been held on 23rd May 1984 were read, confirmed as a true record and signed by the Chairman.
2. Matters of general interest

Danes Hill Reference was made to the dangers on Danes Hill caused by the three-lane marking and the Chairman stated that the Department of the Environment were making some alterations together with minor changes on Deddington Hill.

Footway from Deddington to Hempton It was decided to again ask for a footway along the B4031 between the villages although the County Council had repeatedly refused to take any action.

Road chippings Reference was made to the practice in Northamptonshire of having a suggested speed limit on roads after chippings had been laid and it was decided to ask the County Council to extend this to Oxfordshire.

Domestic refuse bags A complaint was made that one resident in particular was guilty of placing refuse bags outside his house for longer than necessary and it was decided to ask that resident to refrain from doing so.
